7:10 pm - Chairman Prochnow called the meeting to order.
Roll call by Clerk – all members present.
MOTION (Handschke, Laughlin) to approve the meeting's agenda. Carried.
MOTION (Prochnow, Handschke) to approve the minutes from the 10/19/15 Board meeting as corrected. Carried.
MOTION (Laughlin, Handschke) to approve the minutes from the 10/26/15 Special meeting as read. Carried.
MOTION (Laughlin, Handschke) to approve the written Treasurer's Report, subject to audit. Carried.
Kelly LaBrec was recognized. She shared her concerns regarding hunting on private property that is adjacent to the Town's property formerly known as the landfill. Discussion took place with the Board.
Treasurer Tank shares on behalf of the Manawa Area Recycling Center that their hours of operation have changed effective now through 3/31/16. They are now only open Saturdays from 8 am – 4 pm. Starting April 2016, they will revert back to regular hours.
MOTION (Laughlin, Handschke) to approve the following permit(s) issued: Chris Peters – driveway, and Les Prochnow – shed addition. Carried.
MOTION (Handschke, Laughlin) to approve the CSMs submitted each by Blair Laughlin and Paul Gitter. Carried.
