**NOTICE OF SPECIAL TOWN MEETING OF THE ELECTORS OF THE
TOWN OF LEBANON - WAUPACA COUNTY**

Notice is hereby given of a special town meeting of the electors of the Town of Lebanon on Monday, November 18, 2019. This special town meeting will follow the completion of the Public Hearing on the proposed 2020 budget, which begins at 7:00 p.m. at the Lebanon Town Hall, N5844 Buelow Road. This special town meeting of the electors is called pursuant to Sec. 60.12 (1) (c) of Wisconsin Statutes by the Town Board for the following purposes:

- (1) Approve the total 2020 highway expenditures pursuant to Section 81.01 (3) of Wisconsin Statutes;
- (2) Consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2019 by 0.8% percent which would be a dollar increase of \$2742.00;
- (3) Adopt the 2019 town tax levy to be paid in 2020 pursuant to Section 60.10 (1) (a) of Wisconsin Statutes.
- (4) Be it hereby resolved by the town electors of the Town of Lebanon that the town board may hire any elected town official to do part-time work for the town at an hourly wage of \$15.00/hr.

The regular monthly Town Board meeting of the Town of Lebanon will follow the Special Town Meeting of electors.
